**Applications must be received on or prior to April 22, 2018 for consideration as a vendor for the 2018 market season.**

The annual membership dues are \$15.00 per person and are to be submitted with the application to be considered for the market. **Applications received without the membership fee will NOT be reviewed by the board until the membership fee is received.** The membership fee after April 22, 2018 shall be \$20.00 per person and the application will be reviewed at the discretion of the board.

**\*\*\*\*New for the 2018 Summer Market\*\*\*\***

The fee for one (1) tent space for the first half of the market (May 31 – July 26) is \$180.00.

The fee for two (2) tent spaces for the first half of the market (May 31 – July 26) is \$360.00.

**This fee is due before May 25, 2018.**

The fee for one (1) tent space for the second half of the market (August 2 – October 4) is \$200.00.

The fee for two (2) tent spaces for the second half of the market (August 2 – October 4) is \$400.00.

**This fee is due by July 26, 2018.**

**Tent space fees are non-refundable.**

The board of the WAFM strives to bring a unique and balanced mix of vendors to our market each year. Preference for approval of applications is based on vendor type, returning vendor versus new vendor, product mix and any other considerations that the board reasonably believes is necessary to maintain our successful market.
