The WAFM Outdoor Market Season has been extended this year. Our first market will take place on May 23, 2019 and will run through October 31, 2019.

*****There will be one special market on Wednesday, July 3rd so as not to conflict with town 4th of July events. There will be no market on July 4th, 2019.**

Booth Space – Each vendor has a 10' x 10' space to sell their products from. Vendors are allowed to set up an extra tent (located behind your booth space) for shade and storage at no additional fee. If you require more than one tent space to sell product from, the fee for full season and half season vendors is \$9.00 per market. The fee for guest vendors is \$10.00 each market you have the additional tent. The additional fee will be paid to the Market Manager on the date you use the extra tent.

We are offering several options to accommodate our vendors this year. Vendors may choose to attend for the Full Season, Half Season, or as a Guest Vendor.

Full Season Vendors receive a 15% discount. Total amount due for the Full Season is \$408.00.

Full Season Vendors may pay for the entire season in advance or may choose to pay half of the fee prior to May 15th. The second half of the fee must be paid prior to August 1st.

Half Season Vendors receive a 5% discount. The total due for each half season is \$228.00. You must select either Half Season #1 or Half Season #2.

(If you attend for the first Half and decide you would like to stay on through the second Half, you may submit a request to the Board of Directors for approval.)

Half Season #1: May 23 – July 25

Half Season #2: August 1 – October 31

Vendors participating in the first half must pay fee prior to May 15th.
Vendors participating in the second half must pay fee prior to August 1st.

Guest Vendor spaces are designed for farmers with a single short-season crop such as strawberries or blueberries, or vendors who are just starting out and want to see if attending a farmers market is right for them. Guest Vendors are required to follow all rules and regulations of the WAFM. Guest Vendors do not become voting members.

The fee for Guest Vending is \$25.00 per market.

Guest Vendors may attend up to 3 markets during the season, at the Board's discretion. Please list the date (or dates) you would like to attend the market:

If approved, Guest Vendors will be notified and are expected to pay their fees prior to attending the market.

Please enclose the non-refundable \$15.00 application fee with your signed application. Applications received without this fee will NOT be reviewed by the Board. Full Season and Half Season Vendor application fees are applied towards WAFM Membership Fee.

In order to run a successful market, there are expenses that must be paid: advertising, insurance, salary of the Market Manager, taxes, etc. Application fees and booth fees help pay for these expenses. Therefore, **NO REFUNDS** will be issued. If you choose not to attend the market, then you forfeit the fees paid.

All applications are reviewed at the Boards discretion. The WAFM Board of Directors strives to bring a unique and balanced mix of vendors to the market. Approval of applications is based on a combination of factors that include Vendor history, Vendor type, quality and variety of products, supporting local agriculture and local producers of agricultural products, and any other considerations that the Board deems reasonably necessary to maintain the quality and success of the market as a whole.
